- 2. SUMMARY. THE GOA HAS NOTIFIED US THAT ITS COOPERATION WITH THE USG ON HUMAN RIGHTS ISSUES HAS BEEN SUSPENDED UNTIL THE SITUATION OF OUR OVERALL RELATIONS "CLARIFIES". WE SUSPECT THIS IS A PRESSURE TACTIC TO OBTAIN LIFTING OF US SANCTIONS IMPOSED IN CONNECTION WITH FALKLANDS WAR. END SUMMARY.

ON JULY 1, EMBOFF CALLED ON FONMIN OFFICER-IN-CHARGE OF HUMAN RIGHTS ISSUES, COUNSELOR MARCELO COLOMBO MURUA, TO DISCUSS RECENT ANNOUNCEMENT OF PEN PRISONER RELEASES (REFTEL), REQUEST A LIST OF THOSE FREED AND PRESENT A CONGRESSIONAL LETTER REQUESTING INFORMATION ON THE WHERE-ABOUTS OF A DISAPPEARED PERSON. 

THE FONMIN AND THE COOPERATIVE ATTITUDE ON HUMAN RIGHTS DISPLAYED BY THE GOA SINCE THE INCEPTION OF THE VIOLA ADMINISTRATION IN MARCH 1981. THE FOREIGN MINISTRY AND INTERIOR MINISTRY HAVE REGULARLY RESPONDED TO OUR INOUIRIES ON BEHALF OF CONGRESSMEN AND US HUMAN RIGHTS ORGANIZATIONS.
